The Welwyn Hatfield Council hereby **REFUSE** to certify that on the 16/02/2010 the development described in the First Schedule hereto in respect of the land specified in the Second Schedule hereto and shown edged red on the plan attached to this certificate was not lawful within the meaning of Section 192 of the Town and Country Planning Act 1990 (as amended), for the following reason:

1. The proposed development fails to comply with the Town and Country Planning (General Permitted Development) Order 1995 as amended by the Town and Country Planning (General Permitted Development) (Amendment) (No.2) (England) Order 2008, Schedule 2, Part 1, Class B (c) in relation to the additional roof space compared to the original dwelling exceeding the 50 cubic metres allowance.
