REASON: To ensure that the development is carried out in accordance with the approved drawings and any changes must be agreed in advance in writing by the Local Planning Authority.

3. No building or development shall take place until the materials and finish for the proposed folding doors and surrounding frame as annotated on approved drawing 797.04 have been

submitted to and approved in writing by the Local Planning Authority. The approved materials and design shall then be implemented in accordance with these approved details.

REASON: To ensure where possible the original features of the building are to be retained and to comply with PPS5.

4. The materials and mouldings for the proposed French doors as shown on approved drawings 797.04 & 797.06 are to used in the approved development. Any variation to these details and materials are to be approved in writing with the local planning authority.

REASON: To ensure where possible the original features of the building are to be retained and to comply with PPS5

REASONS FOR APPROVAL
