Consent is hereby REFUSED for the following reason(s):-

- 1. The proposed works will have a detrimental effect on the amenity value of the tree and harm the amenity of the area. The proposal is therefore contrary to the East of England Plan 2008, Welwyn Hatfield District Plan 2005 policies GBSP2, R17, D2, D8,
- 2. Insufficient information has been supplied to justify the proposed works. The proposal is therefore contrary to East of England Plan 2008 and Welwyn Hatfield District Plan 2005 policy R17.
- 3. The proposed works are inappropriate for the tree and do not comply with best arboricultural practice. The proposal is therefore contrary to East of England Plan 2008 and Welwyn Hatfield District Plan 2005 policies, R17.

RECOMMENDATION: REFUSAL REASON(S)

The proposal has been considered against the National Planning Policy Framework, East of England Plan 2008 policies; Welwyn Hatfield District Plan 2005 policies GBSP2, R17, D2, D8, in addition to the Human Rights Act 1998, which, at the time of this decision indicate that the proposal should be refused for the reason(s) set out above.
