Decision

Notice is given under article 16 of the Town and Country Planning (Development Management Procedure) (England) Order 2010 that the Hertfordshire County Council as Highway Authority does not wish to restrict the grant of permission.

The amended drawing F9D12-161A(00)111 rev B shows 2 new bollards only in front of the ATM and therefore addresses the earlier concerns of he Highway Authority regarding bollard locations. The bike racks appear to have been relocated to the western side of the building, which leaves the delivery bay free for delivery vehicles. Hertfordshire County Council as Highway Authority considers that the details provided on this amended plan overcome the earlier concerns. Although not a matter for the Highway Authority I note that the bike rack locations will reduce width of the pedestrian access to the rear of the site and the LPA may have a view on this.
