## NOTES:

- This certificate is issued solely for the purpose of section 191 of the Town and Country Planning Act 1990 (as amended)

- 3. This certificate applies only to the extent of the operation/development described in the First Schedule and to the land specified in the Second Schedule and identified on the attached plan.
