# **DESCRIPTION OF SITE:**

The application site is located on garden land to the rear of four properties fronting Hill Rise and Plough Hill. An access road would be inserted between numbers 2 and 4 Hill Rise. The application site is on a hillside and the land level falls steeply from Hill Rise to the properties which are beyond the rear boundary, from the south west to the north west. The application site has trees, scrubs and vegetation which screen the boundaries and characterise the area. At the time of the site visit some mature trees appeared to have recently been felled.
