

I am the owner and resident of 163 Clarkson Court. After viewing the plan of S6/2009/0891/MA – PHASE 4 FORMER HATFIELD AERODROME, I am very upset with this planning application for a numerous good reasons. Hereby, I write to you to state my objection.

I object this application for the following reasons:

- 1) With the planned 4 storey apartment building closely right next to the Clarkson Court and the footpath, as my flat is on second floor, this new building will completely block the light to my bedroom and living room. The whole flat will become very dark. Without much of sun light as me and my baby needed, it will easily develop depression and affect our health.
- 2) The footpath next to the Clarkson Court and the next generation club is right next to my flat. The footpath is very much used and already it is very noisy with passing-by people who talks with just a normal voice. We already suffer lots of noise especially at night. My baby very often is waken up several times Friday, Saturday and Sunday night. With another apartment of 154 flats next to it and access path, we will be suffering from more noise. This again seriously affect our living quality.
- 3) There is already an existing social housing apartment right next to Clarkson court right outside of its gate. I am sure you are aware that there had been a high crime rate badly affected Clarkson court. If now it is to build another existing social housing apartment right next to it on another side of Clarkson court, this will make it even worse. This is unfair to the residence of Clarkson court.
- 4) Clarkson Court, Park House and the new bus station, the new shops had just formed a new focus point of business park. It is good at the moment. I think we should protect this and make it the new Hatfield which people loves. By putting too many social housing so close together to each other and right around this new retail area of business park, I think we are in danger of compromising the security of this area and make it a area of people enjoys less because of it.
