Hi Simon-

Thanks for sending through the **phase 4 site location plan**- that helps to get the bigger picture & full context for the site.

As discussed, when we spoke last Friday 24 July- having now walked around the site & viewed the Grade II* listed former **flight test hanger** at close quarters, the scale of the hanger is so huge & dominant & the separation to the nearest buildings on the proposed site layout sufficient to have only a minimal impact on the setting & context of the former hanger. As such, the relationship is therefore considered to be acceptable.

I took the opportunity to look around the earlier developments of flats & housing adjoining. Some of these are rather successful in introducing a degree of interest & delight into the elevational & general form & appearance of the new buildings. As mentioned, the **Bovis-Street scene 2 illustration** shows the blank wall above the heads of the upper/ second floor windows, to accommodate the low (presumably sheet metal with a standing seam?) pitch of the monopitch roof. If the roof is formed with a sheet metal, it would be possible to introduce a projection at the eaves, front & back, which would introduce a shadow line & would, I feel, help greatly with definition of the roof/ wall junction. I imagine that there is some tanks/ plant etc up in the roof void, together with storage space perhaps- but it might be useful to introduce a small slot window in the roofspace for natural light/ ventilation. Again this would add something to the high level blank wall. The first floor windows are prominent & the framing & detailing makes them an eye-catching element in the appearance of the buildings- so there is sufficient interest generally- it is just that upper wall area.

Other possible ways of adding richness, without over-egging the design, might include the introduction of brick or rendered banding of courses/ lines or recessed or projecting string/band courses. This will provide a subtle level of shadow movement & detail that would be beneficial over all.

Hope that this is helpful. My next <u>BEAMS consultancy day is Friday 7 August</u>- if we need to speak further on this.

Hi Simon-

I copied some of the Stride Treglown/ lavigne.lonsdale Design Statement- May 2009, when I was last at the office on 10 July. Unfortunately I have not had a chance to visit the site as I hoped but have got the gist of the proposed development & have talked over the layout of the proposed **164 no. dwellings** arranged in 2 & a half to 4 storey groups/ blocks & design approach in general terms with Richard Guise.

As discussed, I have great respect for Richard's approach to such sites- & the overall layout seems a sound response to the rather awkward site shape & constraints & the wider context. Some potentially interesting enclosed spaces are created & relatively short linear routes. The parking areas- total 297 spaces- bins & cycle stores/ areas are rather tricky to integrate but this has clearly been carefully thought through as part of the evolution of the scheme.

The relationship to the Grade II* listed 1952- 53 **flight test hanger** is inevitably principally defined by the space separation/ scale/ height/ massing of nearest proposed new buildings. Such a large & significant structure clearly needs its own space & specific context. I would like to look & consider that point at the visit.

Perhaps the Bovis Homes street scene illustrations are deceptive but the elevations seem stark, imposing & somewhat bleak- but maybe you have further detailed drawings of these, that will explain the architectural concept in a rather more positive & less prosaic light- together with lighting/ paving/ edgings/ landscaping/ planting etc.

Hopefully we can discuss further tomorrow afternoon if that would be convenient?
