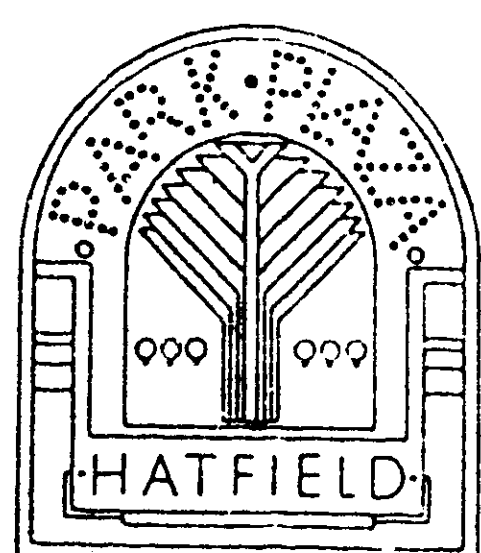

SECOND FLOOR PLAN

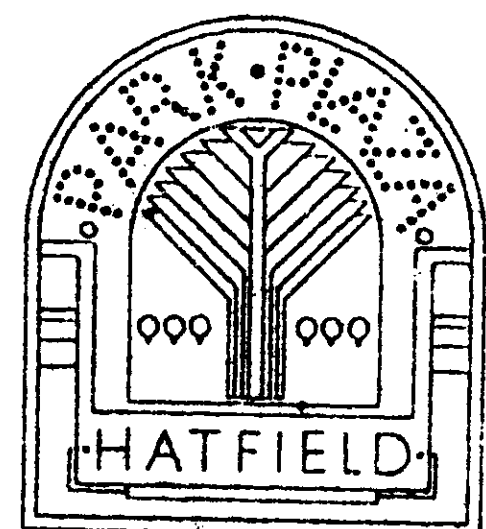
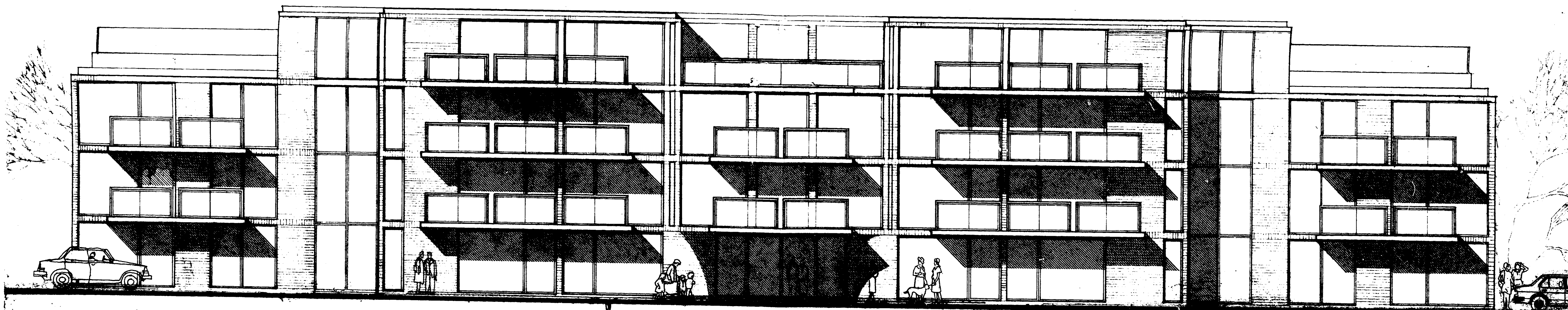

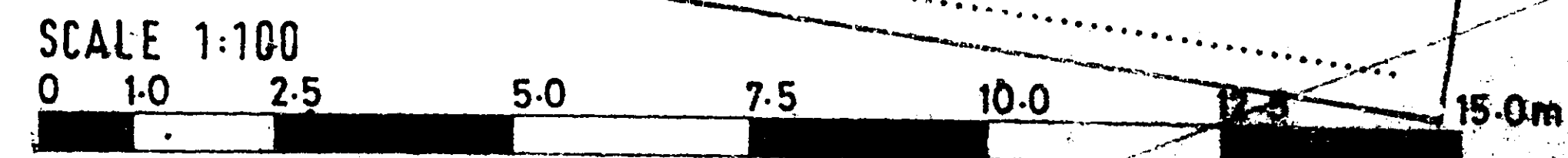

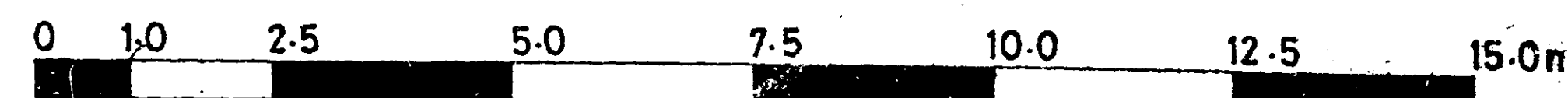
EAST ELEVATION
