## Town and Country Planning Act 1990 PLANNING DECISION NOTICE – REFUSAL

In pursuance of their powers under the above mentioned Act and the Orders and Regulations for the time being in force thereunder, the Council hereby **REFUSE** the development proposed by you in your application received with sufficient particulars on 15/03/2012 and shown on the plan(s) accompanying such application.

The reason(s) for the Council's decision to refuse permission for the development is/are:-

- 1. The proposed development would represent inappropriate development in the Green Belt, due to the proposed replacement dwelling materially exceeding the size of the existing dwelling it is to replace, by reason of the substantial increase in habitable floorspace, volume, footprint, eaves height and ridge height. Furthermore, the proposed development as a result of its prominence, bulk and design would significantly diminish the openness of this part of the Green Belt to the detriment of the character of the area. The proposal is therefore inappropriate development within the Green Belt where the applicant has failed to prove to the satisfaction of the Local Planning Authority, that the harm, by reason of its inappropriateness is outweighed by other considerations contrary to the provisions of Section 9 'Protecting Green Belt Land' contained in the National Planning Policy Framework, March 2012 and Policy RA4 of the Welwyn Hatfield District Plan 2005.
- 2. The Local Planning Authority considers that the applicant has failed to demonstrate the development complies with the requirements of The Conservation of Habitats and Species Regulations 2010 as no appropriate bat survey has been submitted with the application to confirm whether bats are present in the existing roof of the application property. This is contrary to the requirements Policy SD1 and RA11 of the Welwyn Hatfield District Plan 2005, The Conservation of Habitats and Species Regulations 2010
