Thank you for your letter dated 2 January 2019.

My response to the comments made by Welwyn Hatfield Council regarding my planning appeal is as follows:-

- The parking spaces available at the site have always been available for use by my tenants.
   The Council have not produced any evidence to date to prove that they are on the Public Highway.
   Should the spaces have been on the Public Highway I am certain that the Council would have taken action to prevent my tenants from using them.
  - The Council have criticised the drawings submitted but made no attempt to meet with my architect to discuss amendments which I would have been happy to adopt.
  - It should be noted that, apart from my property, there remain only two units which continue to trade as the customer base has diminished enormously over the years.
  - The response to the comments made by Gascoyne Cecil Estates are more than adequately
    addressed by my Tenant whose letter is enclosed and which casts doubt on their credibility,
    especially since they had promised to develop Salisbury Square in 2007 and no work has
    commenced twelve years later.
  - The comment made by Mr Downs indicating that "freeholder owner and the tenant" are "believed to be one and the same" is not only irrelevant but totally erroneous and of course this can be verified at Land Registry.
  - The statements refer to the vibrancy of Salisbury Square but sadly that is something that is not the case. The Square is simply devoid of any passing trade or vibrancy and I would urge a visit on a Saturday night to verify this fact.

I do hope that you will be able to look at my case sympathetically and I look forward to hearing from you in due course.
