

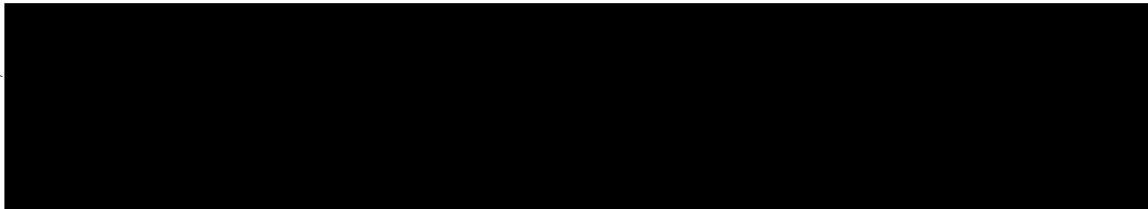

3. Description of the Proposal

Extension of existing house with 2 existing roof level bedrooms, WC, shower room and dressing room:

To front, to enlarge entrance and garage with new roof extension to mirror existing, including matching gable and pitched dormer to front elevation;

To rear to form flat rear wall to existing rearmost line of property, removing existing rear bay window and forming new window and door openings to rear;

Rearward and sideways extension of existing roof to include, lengthened existing side dormer, two new side facing pitched roof dormer windows, extension of existing hipped rear roof to form rear facing glazed gable end, new rear facing pitched roof dormer window projecting from new hipped roof all maintaining existing ridge height;

Adjustment of existing openings to side elevation at ground floor to give 4 no windows in lieu of side entrance way and 3 no windows;

Internal reconfigurations at ground floor level including relocation of staircase, kitchen and utility and removal of ground floor bathroom;

Internal planning of extended roof level to provide 4 bedrooms, 1 bathroom and 2 shower rooms;

New timber deck to give access to sloped rear garden from ground floor level in lieu of existing brick built steps.
