Reason: We have asked for the works to be carried out due to the following reasons: My garden is used by my 83yr old father who suffers with Dementia + Heart failure, this is his only means of outdoor space. We have to continually having to risk + assess the area due to dead wood falling from the tree continually, this is not seasonal.

This is becoming a serious trip hazard for him. As I stated in my email due to the position of the tree the branches overhang the width of my garden. This also leads to a high level of birds mess from birds nesting in the tree. My father, granddaughter and foster children are affected, its becoming a health hazard as the mess covers play area sitting, eating area and the entrance to my patio doors. Several times we've had birds fly into the house, due to the overhanging branches being so close. The birds mess has to be cleared daily, however, this is affecting my health when I attempt this as I am an ~~asthmatic~~ asthmatic. The tree has also uprooted our patio, this was relayed Sept last year by my husband. You will be able to see this on an inspection. I had a tree surgeon confirm that only cutting tree back by 30% would not make any difference ~~to~~ and would not resolve the issue IF the tree cannot be felled it would have to be cut back a considerable amount.
