Prunus cerasifera, black cherry plum (T1) - Crown reduction to reduce the size of the tree and the shading of the small garden. The tree should be reduced evenly by 800mm keeping its shape. The aim is to achieve a natural form while reducing the size. The tree has been previously pollarded (many years ago) so a crown reduction will be beneficial to reduce limb's stress. A few small crossing branches in the inner canopy should also be individually removed.
