Please describe the proposed development including any change of use:

An existing office and side entrance to the northern elevation would be demolished. These would be replaced with a single-storey extension with a total width of 20.5m and an overall depth of 8m. The new layout would conclude a Sunday school / adult baptism area, a vestry, a new office and a consulting / confession room. The proposed extension would be 5.8m in height and would sit below the eaves of the main part of the existing church. The extension would be predominantly flat roofed except for a small section which would maintain the pitched roof form of the existing boiler room. Three timber framed stained glass windows on the current north elevation would be reused for the proposed extension and two new roof lights to the new flat roof, as well as one new roof light to the kitchen's roof. A stone dashed pebble pathway with two new ramps for wheelchair users' accessibility. The elevations would incorporate red brick, stonework and quoins with knapped flint to match existing.
