The tree is question is a large leylandi, approximately 25ft tall. This will be felled by a professional tree surgeon leaving a root stump. This tree was planted by ourselves when we bought the property some 26 years ago. As our garden is relatively small (30ft x 40ft) it has now grown too big and is giving excess shade to the garden. This has a detrimental effect on the lawn and on shrubs close by.						
There is also a concern regarding the closeness to our property if it is allowed to continue to grow bigger.						
We will plant some flowering shrubs in the adjacent area.						
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
