G1 - cypress - Fell

G1 comprises two Lawson cypress trees which we presumably planted as a hedge and then left unmanaged. The trees have now grown out of control and their aggressive root system which is harming nearby walls and kerb stones and this will worsen if the trees are allowed to grow larger.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
