Oak tree at the rear of the property. Full crown reduction to be carried out. Overall reduction of 30% approximately 4 metres from top and 3 metres from sides. The tree has not been maintained for many years and is very overgrown. The branches to the side are overhanging the roof of the house and near to making contact. If they were to break as a result of poor weather, they would cause a lot of damage to the roof structure of the house. As a result of it being overgrown, the rear garden does not receive direct sunlight even though the garden is south facing. The patios stay damp all year round and become hazardous under foot due to a build up of mould. We have started to notice movement on the rear flank wall of the house on the side that the tree is situated.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
