Please see the tree marked as 'A' within Document A, based off a sketch derived from our house title.

It is a large leylandii situated at the rear-left corner of our property.

The tree has grown substantially in the last couple of years and we want hire a tree surgeon to trim the crown to approximately half of the current size, as it is starting to block light from properties, and also it is encroaching into the gardens of neighbouring properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
