All identified tree works are for H&S reasons (Stage 2 and Stage 3 ADB, plus structural decay resulting from fire damage)

All trees to be felled to ground level.

All arisings to be used to block access to the site to prevent further fire damage and unauthorised access by 4x4s.

No re-planting proposed as felling is in a woodland setting, with natural regeneration present as well as suppressed intermediates & juvenile trees that will be released into the the upper canopy by proposed works.
