Identification of Tree(s) and Description of Works

I have 2 Oak trees in my garden T5 and T6

For safety, tree aesthetics and allowing light into garden I regularly remove the adventitious growth that occurs. The last work was in April 2019. I have taken photos of the growth on both tress and can supply then as needed.

The growth on T6 for consideration is same as before in 2019. Removal of adventitious growth from ground level into start of main crown. Approx 6m for stems approx 2-4 cm thick.

T5 has just in one spot of adventitious growth , halfway up the trunk with around 5 stems emerging from one place that makes the trunk unbalanced visually. This growth consists of around 6 very thin stems.

The work will be carried out by a qualified tree surgeon. There are no birds nesting in the tree when checked.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
