Fir tree in rear garden. This tree is very tall bearing in mind the proximity to property and size of my garden, estimate of height around 25 metres. Other smaller fir trees at end of rear garden have been pollarded following permission granted around 4 years ago. The fir tree in question has been seen by your surveyor who authorised previous works. I am concerned at the height of the tree and possible future damage to property foundations. Also, a danger if it came down in stormy weather. Requesting permission to remove this tree.
