We are writing to you with regard the above noted development which was approved on 24 March 2022 and on behalf of New Ways Ltd as main contractor for these works.

In relation to this we wish to discharge Condition **<u>8</u>**.

This condition states the following:

"Piling/other foundation designs using penetrative methods must not be carried out other than with the written consent of the local planning authority."

REASON: To ensure that the development will not exacerbate the bromate and bromide groundwater pollution beneath the site, in accordance with Policies R2 and R7 of the Welwyn Hatfield District Plan 2005, Policies SP 10 and SADM 18 of the Welwyn Hatfield Borough Council Draft Local Plan Proposed Submission August 2016, and the National Planning Policy Framework.

Our proposed foundation design utilizes a reinforced concrete piled foundation based on the design prepared on the attached drawings and schedules by chartered structural engineers, TAK Structures Ltd.

We herewith submit a copy of the drawings and pile schedules which pertain to the development.
