### Important – Planning permission and notices of consent

### **Compliance with conditions**

- Your planning approval or consent is attached. It will contain conditions that you must comply with.
- Please read the conditions and understand their requirements and restrictions, for example submission and approval of details or measures to protect trees.
- Some conditions will require action before you start development and it is imperative that you seek to have these discharged before any work commences.
- Whilst every effort has been made to group conditions logically, it is your responsibility to ensure that you are aware of the requirements and/or restrictions of all conditions.
- If you fail to comply with the conditions this may result in a breach of planning control and this may lead to enforcement action.
- Failure to comply with conditions may also result in the development not being lawful.
- It is in your interests to demonstrate that conditions have been complied with. Failure to do so may cause difficulties if the property is sold or transferred.
- A fee may be payable for each request to discharge conditions.

1. The development hereby permitted shall be carried out in accordance with the following approved plans: 703/LP1, 207, 703/210A, submitted on the 6th September 2017 as part of planning application 6/2017/2001/FULL and plan 207 (parking plan) submitted as part of the appeal and dated 30 April 2018.

REASON: To ensure that the development is carried out in accordance with the approved plans and details.

2. The two car parking spaces delineated on plan no 207 (marked 'Plan to show 2 No Car Park Spaces for Residential Flat for visiting family members') shall be retained in perpetuity for the occupants of this residential flat.

REASON: To ensure that adequate parking provision is provided for the future occupiers of the flat in the interests of highway safety in accordance with the National Planning Policy Framework.

3. The residential flat hereby permitted shall not be occupied at any time other than for purposes ancillary to the residential use of the dwelling known as Warrenwood Manor.

Reason: To ensure that the flat is limited to being occupied by purposes ancillary to Warrenwood Manor.

### **Town and Country Planning Act 1990**

### Appeals to the Secretary of State

- If you are aggrieved by the decision of your local planning authority to refuse permission for the proposed development or to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of The Town and Country Planning Act.
- If this is a decision on a planning application relating to the same or substantially the same land and development as is already the subject of an enforcement notice, if you want to appeal against your local planning authority's decision on your application, then you must do so within 28 days of the date of this notice.
- If an enforcement notice is served relating to the same or substantially the same land and development as in your application and if you want to appeal against your local planning authority's decision on your application, then you must do so within: 28 days of the date of service of the enforcement notice, or 12 weeks in the case of a householder appeal of the date of this notice, whichever period expires earlier.•
- As this is a decision to refuse permission for a householder application, if you want to appeal against your local planning authority's decision then you must do so within 12 weeks of the date of this notice:
- Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN or online at www.gov.uk/governmentlorganisations/planning-inspectorate.
- The Secretary of State can allow a longer period for giving notice of an appeal, but will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to the Secretary of State that the local planning authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.

In practice, the Secretary of State does not refuse to consider appeals solely because the local planning authority based their decision on a direction given by the Secretary of State.

### **Purchase Notices**

• If either the local planning authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that the owner can neither put the land to a reasonably beneficial use in its existing state nor render



the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.

• In these circumstances, the owner may serve a purchase notice on the Council in whose area the land is situated. This notice will require the Council to purchase the owner's interest in the land in accordance with the provisions of Chapter I of Part 6 of the Town and Country Planning Act 1990.

### WHY DO I NEED BUILDING CONTROL?

There is a legal requirement that work carried out on buildings, including alterations, extensions and garage and loft conversions are inspected and certified by an authorised Building Control body Building Control protects the innerests of the property owner ensuring that architects and buildings chartol protects the instandards required in the Building Regulations. Sadly, there are a number of rogue operators who will out coverners to save themselves money and in doing so coare buildings to be unsafe, difficult to access or exit, and energy inefficient. The building control surveyor is there to ensure that standards are achieved to and to certify the work carried out. This is not only important for you when living in your property but. also when you come to sell it, as it could delay or prevent a sale if the appropriate certification has not been completed.

### IS THIS DIFFERENT FROM PLANNING?

Building Control is separate from planning which deals with the appearance of buildings and how they fit into their environment. Your project may also need planning consent, which is a different process.

Building Control Surveyors work on behalf of the property owner and with architects, buildings and other construction professionals to bed the compliance process, certifying that buildings conform to Building Regulations.
