Context	
Site and Application description	<p>The application site is located to the south of St Albans Road West and is comprised of a two-storey semi-detached dwelling with front driveway and elongated rear garden. The area is residential in character comprising of a semi-detached dwellings uniform in character. Many of the properties in this part of St Albans Road West have been previously extended.</p> <p>This application follows recently approved application 6/2022/0100/HOUSE which was for the erection of a single storey front, part single, part two storey rear and first floor side extensions.</p> <p>This application (6/2022/2515/HOUSE) is also for the erection of a single storey front, part single, part two storey rear and first floor side extensions. However, this application reduces the front extension in size and roof form as well as altering the fenestration of the dwelling compared the development approved under application 6/2022/0100/HOUSE.</p>

Comment (if applicable): The principle of the proposed development has been approved under 6/2022/2515/HOUSE and as such does not need to be considered further within this application. This current application proposes a reduction in size to the previously approved front elevation with a hipped roof in place of the approved monopitch roof. The reduction in size would ensure the development remains subservient towards the application dwelling and the hipped roof would not detract from the character and appearance of the application dwelling or wider area. The alteration to the fenestration in this application compared to previously approved application includes reduction in window size within the ground-floor front facing elevation, removal of the window in the ground-floor flank elevation and increase in size for the first-floor rear elevation. These alterations would remain in keeping with the appearance of the dwelling and would not detract from the character of the dwelling. Matching materials can be secured by condition to ensure that the development would remain in keeping with the character and appearance of the application dwelling and wider area.

Under previously approved application 6/2022/0100/HOUSE it was considered in regard to sunlight and outlook that the positioning, size and scale of the proposal would not result in an undue loss of light to adjoining neighbours, nor would the development appear unduly dominant. The same conclusion is made for this subsequent application. In terms of privacy, the position and scale of the fenestration would not result in adjoining neighbours to experience an undue loss of privacy.

Conditions:

1. The brickwork, roof tile, bond, mortar, windows, detailing, guttering, soffits and other external decorations of the approved extension must match the existing dwelling in relation to colour and texture.

REASON: To ensure a satisfactory standard of development in the interests of visual amenity in accordance with Policies D1 and D2 of the Welwyn Hatfield District Plan 2005 and the National Planning Policy Framework.

1. POSITIVE AND PROACTIVE STATEMENT

The decision has been made taking into account, where practicable and appropriate the requirements of paragraph 38 of the National Planning Policy Framework and material planning considerations do not justify a decision contrary to the development plan (see Officer's report which can be viewed on the Council's website or inspected at these offices).

1. This permission does not convey any consent which may be required under any legislation other than the Town and Country Planning Acts. Any permission required under the Building Regulations or under any other Act, must be obtained from the relevant authority or body e.g. Fire Officer, Health and Safety Executive, Environment Agency (water interest etc.) Neither does this permission negate or override any private covenants or legal interest (easements or wayleaves) which may affect the land.
2. Any damage to the grass verges caused by the development/works hereby approved is the responsibility of the applicant and must be re-instated to their original condition, within one month of the completion of the development/works. If damage to the verges are not repaired then the Council and/or Highway Authority will take appropriate enforcement action to remedy any harm caused.
3. The applicant is advised to take account the provisions of The Party Wall Act 1996 insofar as the carrying out of development affecting or in close proximity to a shared boundary.
4. In addition, and separate to your planning permission, for the majority of schemes, you are required by law to appoint a building regulator who will inspect your property at various stages during the course of your building project. This is to ensure it is compliant with the Building Regulations and the Building Act 1984.

The checks the building regulator will carry out include, but are not limited to, the structure, foundations, fire precautions and escape routes, electrical and plumbing compliance and other issues such as drainage and insulation. The objective of these checks is to ensure that your building is safe to live in, accessible and environmentally sustainable.

Once all build stages are checked and the works are finished, a Completion Certificate is issued confirming that these objectives have been met. You will also need the Completion Certificate, should you sell the property, as it will confirm to future owners that the work has been carried out in compliance with the Regulations.

As the owner of the property, you are responsible for Building Regulations compliance so we would urge you to decide which regulator to use, as opposed to leaving your builder or architect to make the choice. This is so that you can be sure the building regulator is truly independent and working to protect you from any breach or omission during the works.
