Main Issues				
Appropriateness of the works in relation to the tree(s)	The oak tree is a mature tree standing in the rear garden of the property, abutting the boundary with house 2. The tree is large in stature and very much feels part of the silvern character of the area, and also part of the wider Hook Wood. The tree is slightly thin of leaf, but this is not indicative of decline. The odd secondary piece of deadwood is visible. Overall, the tree appears to be in fair to reasonable health, reduced vitality, and structural condition. The tree has a high lift over the applicant's garden, but a few of the branches over the neighbouring garden hand lower. There are applicant fears that these may become caught by the wind etc and fail. A crown lift to 5m over the neighbouring garden would reduce these branches back significantly whilst retaining the profile of the underside of the crown. There is some epicormic growth on the stem. The removal of this is negligible. The proposed tree works are reasonable.			
Conclusion				

The proposed tree works are justified and proportionate given the justification and reasoning for it and the application should be approved.
