Submission of details pursuant to conditions number 3 (remediation strategy), 4 (monitoring and maintenance plan), 6 (material samples), 10 (external lighting), 13 (remediation verification report), 14 (unexpected contamination), 15 (borehole installation scheme) and 16 (intrusive groundwork consent), on planning permission 6/2021/2260/FULL.

Thank for your consultation on the above discharge of conditions application. As part of the consultation, we have reviewed the following documents:

- Shell Welwyn Garden fuel retail station Phase 2 investigation RSK Geosciences Report No. 1922098-R03 (01) Rev 01 dated April 2022
- Shell Welwyn Garden Environmental Strategy Plan RSK Geosciences Report No. 1922098 R04 (02) dated April 2022

## **Environment Agency's Position**

After a review of the submitted information, we are able to recommend the discharge of conditions 3 (land contamination), 4 (monitoring and maintenance), 15 (borehole management) and 16 (intrusive groundwater consent). However, we do not recommend the discharge of conditions 13 (verification report) and 14 (unexpected contamination) at this time.

Please find our comments related to each condition below:

#### Condition 3 – Land Contamination

We are able to recommend the discharge of Condition 3 at this time.

#### **Condition 4 – Monitoring and Maintenance**

We are able to recommend the discharge of Condition 4 at this time.

### **Condition 13 – Verification Report**

A full verification report can only be submitted once remediation works on site and associated verification monitoring have been completed. Therefore, we cannot recommend the discharge of Condition 13 at this time.





### **Condition 14 – Unexpected Contamination**

This is a compliance condition that is in place to mitigate against potential risks should any contamination not picked up in the site investigation be later discovered. It would not be appropriate to discharge this condition prior to or whilst development works are ongoing and so we cannot recommend discharge of Condition 14 at this time.

# **Condition 15 – Borehole management**

We are able to recommend the discharge of Condition 15 at this time.

## **Condition 16 – Intrusive groundwater consent**

It is our understanding that there will be no deep piling/foundation works for this development. As such we are able to recommend the discharge of Condition 16 at this time. We would expect to be reconsulted should there be any change to the site design which would require deep foundations.
