Thank you for your consultation on the above discharge of conditions application and apologies for the delay in our response. As part of the consultation, we have reviewed the following:

Environment Agency's Position

Two of the above-mentioned planning conditions were proposed by the Environment Agency; namely Condition 7 (drainage) and Condition 8 (foundations). After a review of the submitted information, we are in the position to **recommend discharge of Condition 7 (drainage)** at this time. However, we are **unable to recommend discharge of Condition 8 (foundation)** based on the submitted information. Please see the details below.

Condition 7 (drainage)

We recommend the discharge of this planning condition based on the submitted information. We are satisfied that the proposed drainage poses a low risk of exacerbating the bromate and bromide groundwater pollution beneath the site because the scheme does not infiltrate water into the ground and porous /permeable surfaces are lined.

Condition 8 (foundation)

We are unable to recommend the discharge of this planning condition based on the submitted information.

There are two exploratory holes logs that provide information about the geology encountered at the anticipated depths of the proposed CFA piles: CP01 and CP02. Both indicate the piles will terminate at or close to the interface between a clay aquitard, which separates the upper and lower gravel aquifers, and the top of the lower gravels. This interface is likely to vary across the site and so some piles will puncture through the clay aquitard. The lower gravels lie directly on top of the chalk aquifer. Groundwater in the lower gravel aquifer is known to be in hydraulic continuity with the chalk aquifer and bromate and bromide pollution lies within these gravels as well as the Chalk.

Please provide further information on how it will be ensured that the upper and lower gravel aquifers are kept separate throughout piling activities and the life of the development, so that the existing bromate and bromide pollution does not exacerbate.
