Erection of a double storey side and single storey rear extension, front porch with access, driveway and frontage alterations

Decision

Notice is given under article 18 of the Town and Country Planning (Development Management Procedure) (England) Order 2015 that the Hertfordshire County Council as Highway Authority does not wish to restrict the grant of permission subject to the following conditions:

Conditions

Condition 1

Prior to the first occupation of the development hereby permitted any access gate(s), bollard, chain or other means of obstruction shall be hung to open inwards, set back, and thereafter retained a minimum distance of 6 meters from the near channel edge of the adjacent carriageway . Any sidewalls / fences / hedges adjacent to the access shall be splayed at an angle of 45 degrees from each of the (outside) gateposts to the front boundary of the site

Reason: To enable vehicles to safely draw off the highway before the gate is opened.

Condition 2

Construction Traffic (Parking)

SHC 25: Development shall not commence until a scheme detailing provision for on-site parking for construction workers for the duration of the construction period has been submitted to and approved in writing by the Local Planning Authority. The scheme shall be implemented throughout the construction period.

Reason: To ensure adequate off-street parking during construction in the interests of highway safety.

Storage of materials AN1) Storage of materials: The applicant is advised that the storage of materials associated with the construction of this development should be provided within the site on land which is not public highway, and the use of such areas must not interfere with the public highway. If this is not possible, authorisation should be sought from the Highway Authority before construction works commence. Obstruction of the highway AN2) Obstruction of public highway land: It is an offence under section 137 of the Highways Act 1980 for any person, without lawful authority or excuse, in any way to wilfully obstruct the free passage along a highway or public right of way. If this development is likely to result in the public highway or public right of way network becoming routinely blocked (fully or partly) the applicant must contact the Highway Authority to obtain their permission and requirements before construction works commence. Comments The proposal is for works to the private residential dwelling situated at 44 The Ridgeway,, a 40mph secondary distributor road west of Cuffley.

There are no accidents recorded that would be associated with the sites access or its function in the previous five years according to our records.

The application for state4s that amendments to the access form the public highway are proposed, upon review this does not appear to be the formation of any additional accesses to the site, with the site having two vehicle access points currently. it would appear minor works are proposed including the addition of gates to the access. Due to the nature of The Ridgeway and its function as a secondary distributor road, it is conditioned that the gates be a minimum of 6 meters from the carriageway nearside edge, so as to ensure vehicles can fully draw off of the carriageway, as there is no footway this is unlikely to impede pedestrians.

the remainder of the proposal would be unlikely to impact highway safety

the changes would not give rise to a change in trip generation achievable at the site.

Due to the location, it is conditioned that a plan ensuring no on street parking during construction
