Dear Ms Mugova,

I am writing in regards to the application attached and any other further applications no. 5 West View intends in the future . My name is [REDACTED] and I live with my family at 7 West View, I have [REDACTED] small children aged [REDACTED] and [REDACTED] 6 years old. Ever since we've moved to this address, we've had on numerous occasions the door bell ringing in the middle of the night because of no. 5 West View. People would just come and ring the doorbell, I have [REDACTED] small children, so many times I am [REDACTED] in the house and I panic, I feel scared I do not feel safe in my own house.

I do not feel safe leaving my children in my own garden because of the people that come to no5. As you can understand it is a low budget hostel and it attracts all sorts of people. We had numerous police incidents at no 5. This is a residential area, this should be a safe place to raise our children. I want to feel safe at home with my children, it is what every mother wants. People coming to no 5 create parking chaos as they rarely use the their own parking spaces, they prefer to park on the kerbside on West View.

The life quality on West View and Birchwood area is degrading because of no.5 .

We have common fences with no.5 West View, even we paid and fitted fences, they leaned all sorts of things against it , now it is all green and degrading because it's not ventilated.

At the moment they want to build offices in their back garden. That will deprive everyone around of any sorts of privacy. They will have full view inside my living room, my kitchen, bedrooms , garden. This is not acceptable. I hope you get the real facts, this is not going to be just offices, they are applying for that, but thinking of the future, those offices will become hostel rooms, it is so predictable. That should not exist in the first place. What about us, the taxpayers who are living there? Our life quality doesn't matter? What about the parking traffic it creates?

What about the police incidents it creates? What about OUR CHILDREN SAFETY?

Because no 5 is a corner property, all houses will be deprived of privacy in their own home. It's horrible to even think about it.

Do you have little children? Any parent wants to be able to look after their children's safety.

Over 2 weeks, I have a van parked outside my house, and nobody takes action? I can't park my car outside my own house because of no 5.

At no 6 West View, my neighbour [REDACTED], had people jumping the fence from no5 West View, running from police. And [REDACTED] [REDACTED] [REDACTED], she gets scared and she calls me or my husband. It's not nice, she's been through so much already.

At no 8 West View we have [REDACTED] [REDACTED] [REDACTED] [REDACTED], [REDACTED] [REDACTED], [REDACTED] come several times a day to look after her. So many times [REDACTED] need to come to her and they can't access because there are cars parked outside her home.

I hope you will consider the community as a whole, the safety, the life quality.

I am willing to go anywhere needed, from local MP all the way to parliament. I want a safe space for all, that's what we deserve in our community.
