## Annex A National Highway's assessment of the proposed development

National Highways has been appointed by the Secretary of State for Transport as a strategic highway company under the provisions of the Infrastructure Act 2015 and is the highway authority, traffic authority and street authority for the Strategic Road Network (SRN). The SRN is a critical national asset and as such we work to ensure that it operates and is managed in the public interest, both in respect of current activities and needs as well as in providing effective stewardship of its long-term operation and integrity.

## **Statement of Reasons**

National Highways' interests relate to the operation and safety of the SRN, and in proximity to the proposed site, this includes the A1(M). We are interested as to whether there would be any adverse safety implications or material increase in queues and delays on the SRN because of this proposal.

We have reviewed the planning application documents which are available on the portal and believe this proposal would be unlikely impact the safety, reliability and / or operation of the SRN. This is because the proposed illuminated signage is unlikely to be visible from the A1(M) due to the difference in grade, the distance from the site and the dense vegetation and buildings present. The proposals are also unlikely to have any impact on traffic levels due to the nature of the development.
