3. Description of Proposed Works

Please describe the proposed works:

- The proposal is for the addition of an outbuilding (greenhouse) within the site boundary of 'The Gable House'.
- The Gable House is a Grade II listed mews style property - one of the three residencies with private gardens and access off a shared courtyard. These residencies were significantly refurbished, extended and converted in 1997.
- The proposed greenhouse is part of the Alitex National Trust range, with a footprint of 4077mm x 2577mm. The ridge height of the greenhouse is 2972mm.
- The proposed location of the greenhouse is 20m from the rear of the property, and 4m away from the nearest boundary. A tall brickwall, with high-level planting and trees, runs along the site boundary, further concealing the garden from the neighbouring property.
- It is considered that the proposed greenhouse causes no detriment to the existing or neighbouring properties, and is in keeping with the size, scale and style of the existing property and the surrounding garden.
- The greenhouse will also not be visible from any neighbouring properties or main roads.
