In pursuance of their powers under the above mentioned Acts and the Orders and Regulations for the time being in force thereunder, the Council hereby grant express consent to the display of the advertisement proposed by you in your application dated 05/09/88 and received with sufficient particulars on 22/09/88 and shown on the plan(s) accompanying such application.

The consent is granted for the period of five years from the date hereof, and subject to the following conditions:-

1. The luminance shall comply with the conditions set out in Technical Report No.5 of the Association of Public Lighting Engineers, or chapter 11 of the Traffic Signs Manual.

Reason

So that drivers of vehicles along the County Road are not dazzled or distracted, leading to interference to the free and safe flow of traffic along the highway.

2. All advertisements displayed, and any land used for the display of advertisements, shall be maintained in a clean and tidy condition to the reasonable satisfaction of the Local Planning Authority.
3. Any hoarding or similar structure, or any sign, placard, board or device erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition to the reasonable satisfaction of the Local Planning Authority.
4. Where any advertisement is required under the Town and Country Planning (Control of Advertisements) Regulations 1969, to be removed, the removal thereof shall be carried out to the reasonable satisfaction of the Local Planning Authority.

The reason for conditions 1-3 is to comply with the Control of Advertisement Regulations 1969.
