SUFFER WITH ADVENTITIOUS GROWTH. TREE TS MORE SO THAN T6. TS WAS GRANTED PERMISSION & THE TRUNK WAS CLEANED OF THE LATERAL SHOOTS. T6 DID NOT NEED ANY WORK, HOWEVER OVER THE YEARS THE SHOOTS HAVE GROWN AND NOW IN NEED OF SHORTENING. THEREFORE I SEEK CONSIDERATION REGARDING MY REQUEST TO REMOVE LATERAL LENGTH OF ADVENTITIOUS GROWTH UP TO 6M HIGH. THE LATERALS I ESTIMATE ARE NO THICKER THAN 2-4 CM IN DIAMETER. I DID APPLY FOR PERMISSION IN DEC 18 - HOWEVER MY SKETCH PLAN WAS NOT RECEIVED. AND THE REQUEST WAS CLOSED. AS SUCH I RESUBMIT AND GIVE PERMISSION FOR THAT INCLUDING THE PHOTOS THAT WERE ATTACHED.
