Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

(T1) Oak - Reduce height and spread by up to 1.5-2m, works to be carried out for general tree maintenance and to access more light into garden and property. Branches are encroaching over gate house causing mess on roof/guttering and allowing squirrels to jump onto roof causing damage to property. Remove major dead wood for safety.

(T2) Oak - Reduce height and spread by up to 1.5-2m, works to be carried out for general tree maintenance. Branches are encroaching over gate house causing mess on roof/guttering and allowing squirrels to jump onto roof causing damage. Remove major dead wood for safety as the tree is situated by the main entrance.

(T3) Oak - Reduce height and spread by 2m (please see picture attached) to re shape/balance and for general tree maintenance. Reduce back and branches encroaching over camera for clearance. Remove major dead wood for safety as located by the main entrance.

(T4) Oak - Reduce height by 1.5m, reduce spread by 2-2.5m as branches are encroaching into adjacent Oak tree. Remove all ivy where possible as this can cause unwanted damage, remove major dead wood to make safe as located by main entrance, to access more light into gate house and for general tree maintenance.

(T5) Oak - Reduce height by 1.5m, reduce spread by 2-2.5m as branches are encroaching into adjacent Oak tree. Remove all ivy where possible as this can cause unwanted damage, remove major dead wood to make safe as located by main entrance. This is for general tree maintenance.

(T6) Oak - Reduce height down by 2.5m, reduce spread by up to 1- 1.5m (please see picture attached) for general tree maintenance and to reduce the sail from the canopy of the tree hoping to prevent any future storm/wind damage. Remove major dead wood for safety of the public.

All of the above trees have been worked on many years ago and have not been reduced since. The job will be classed as general tree maintenance/safety and the Oak trees will only be cut during the winter period while dormant to rule out any future damage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
