

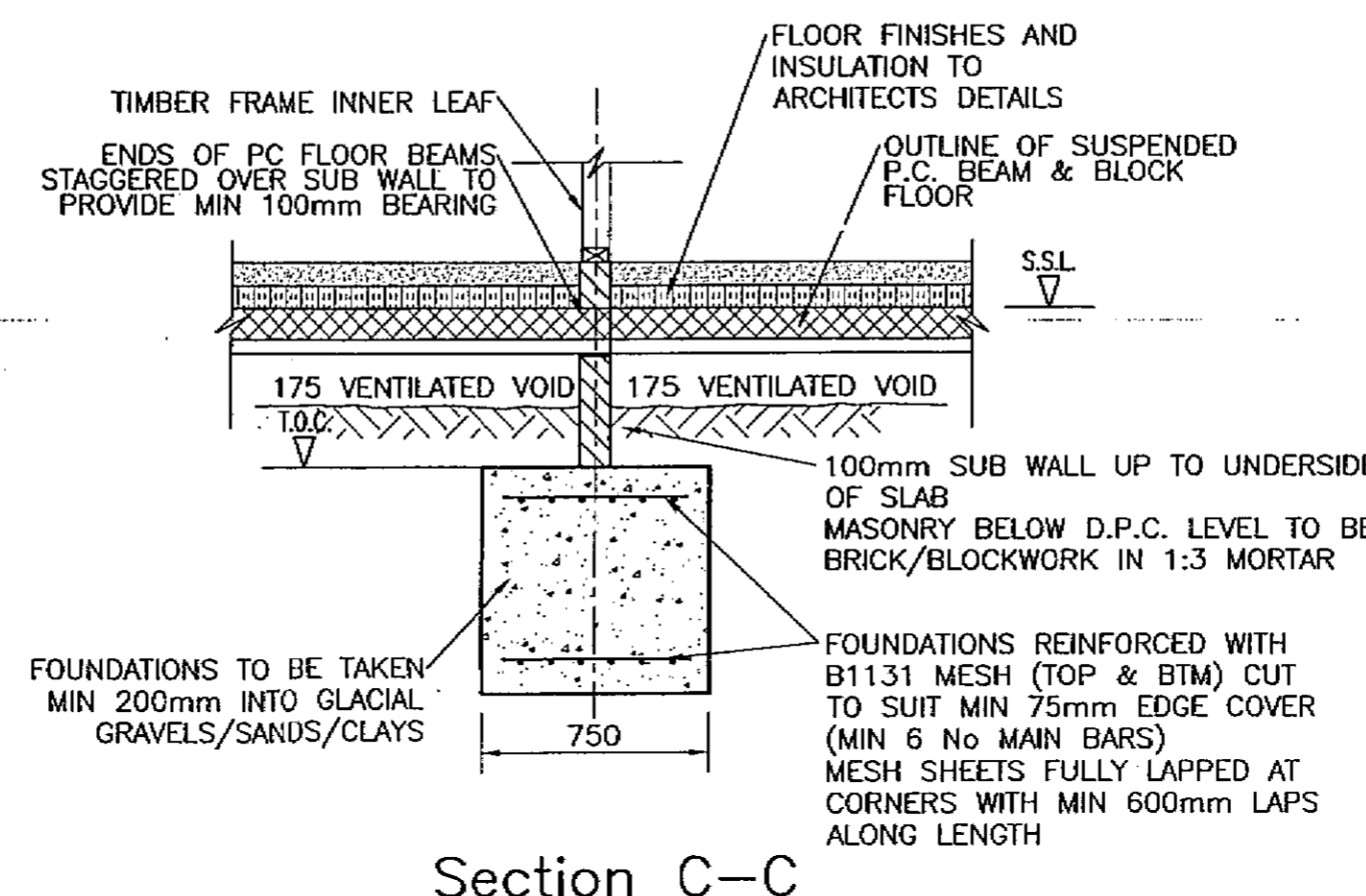

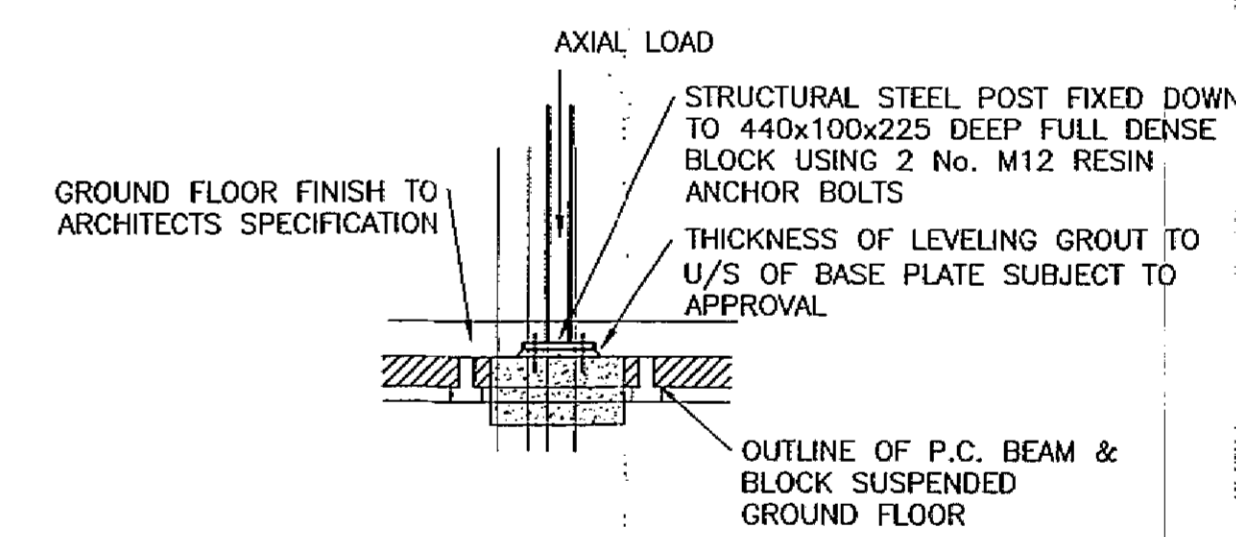

FOUNDATION LAYOUT**

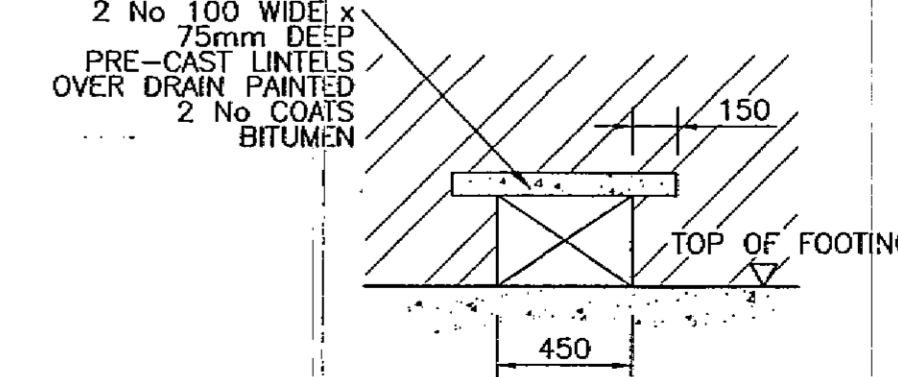
