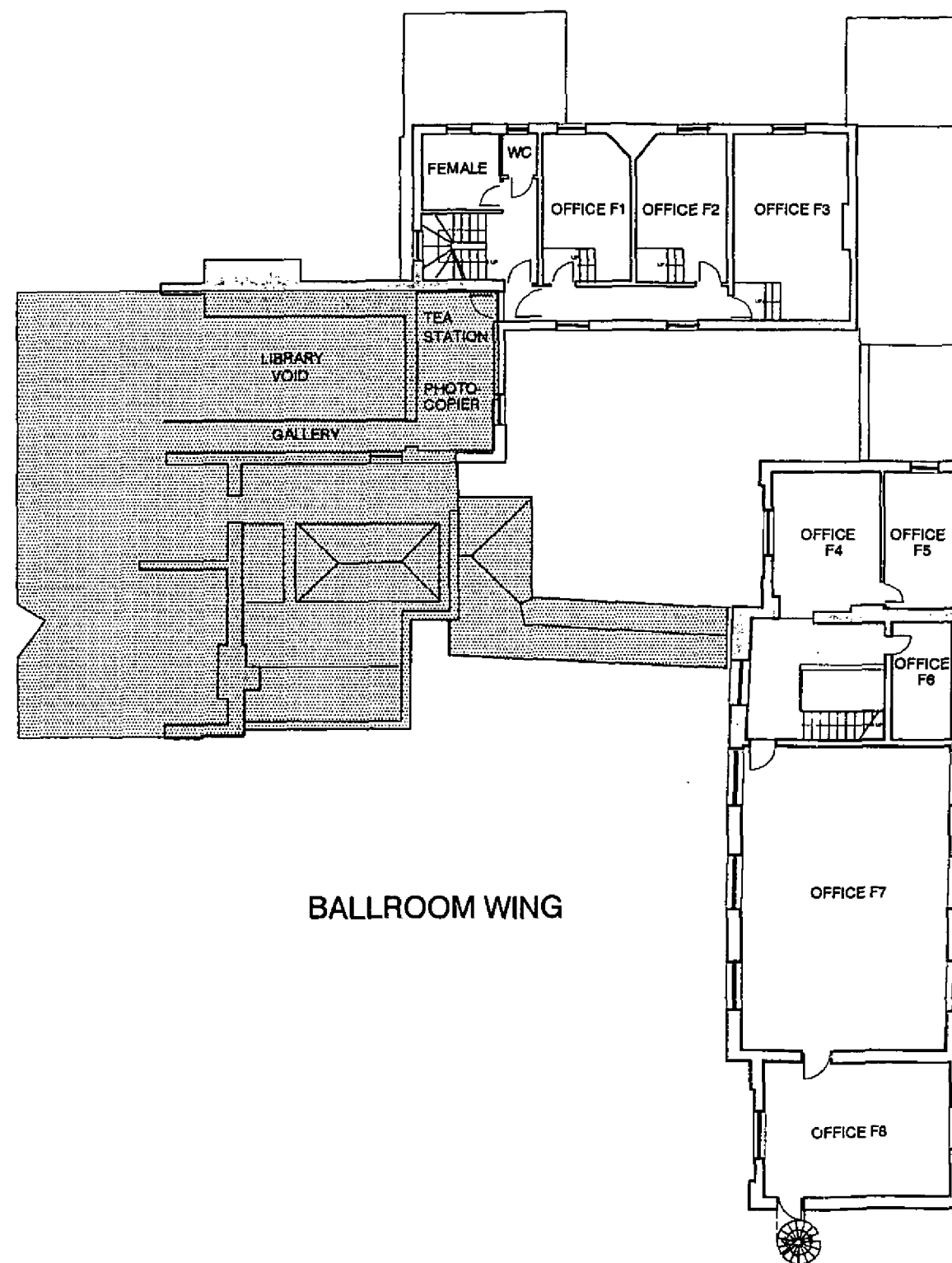

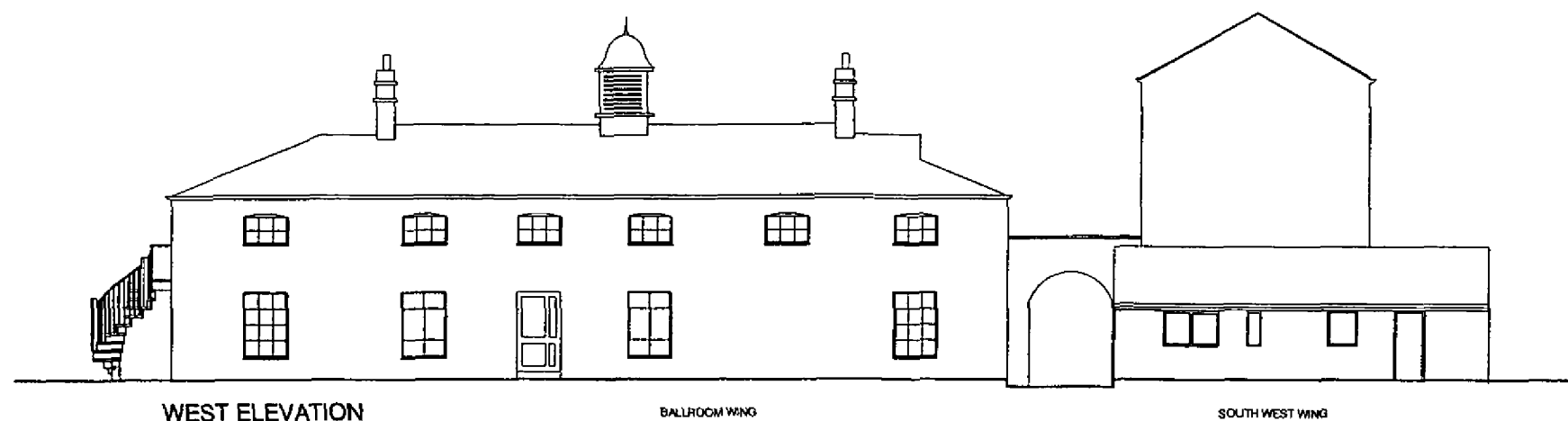

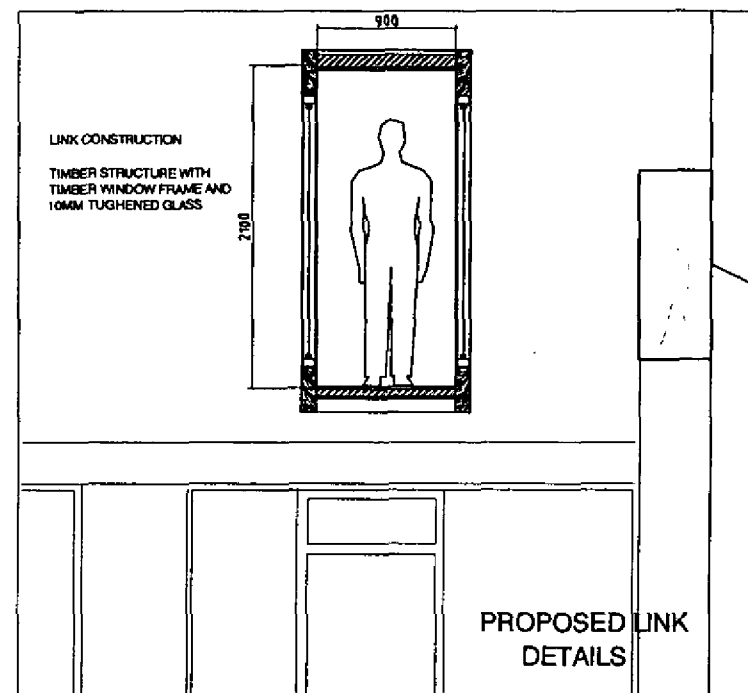

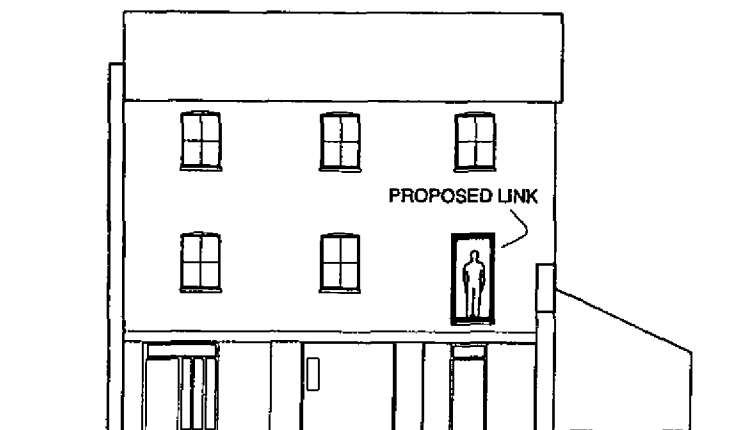
WEST ELEVATION
