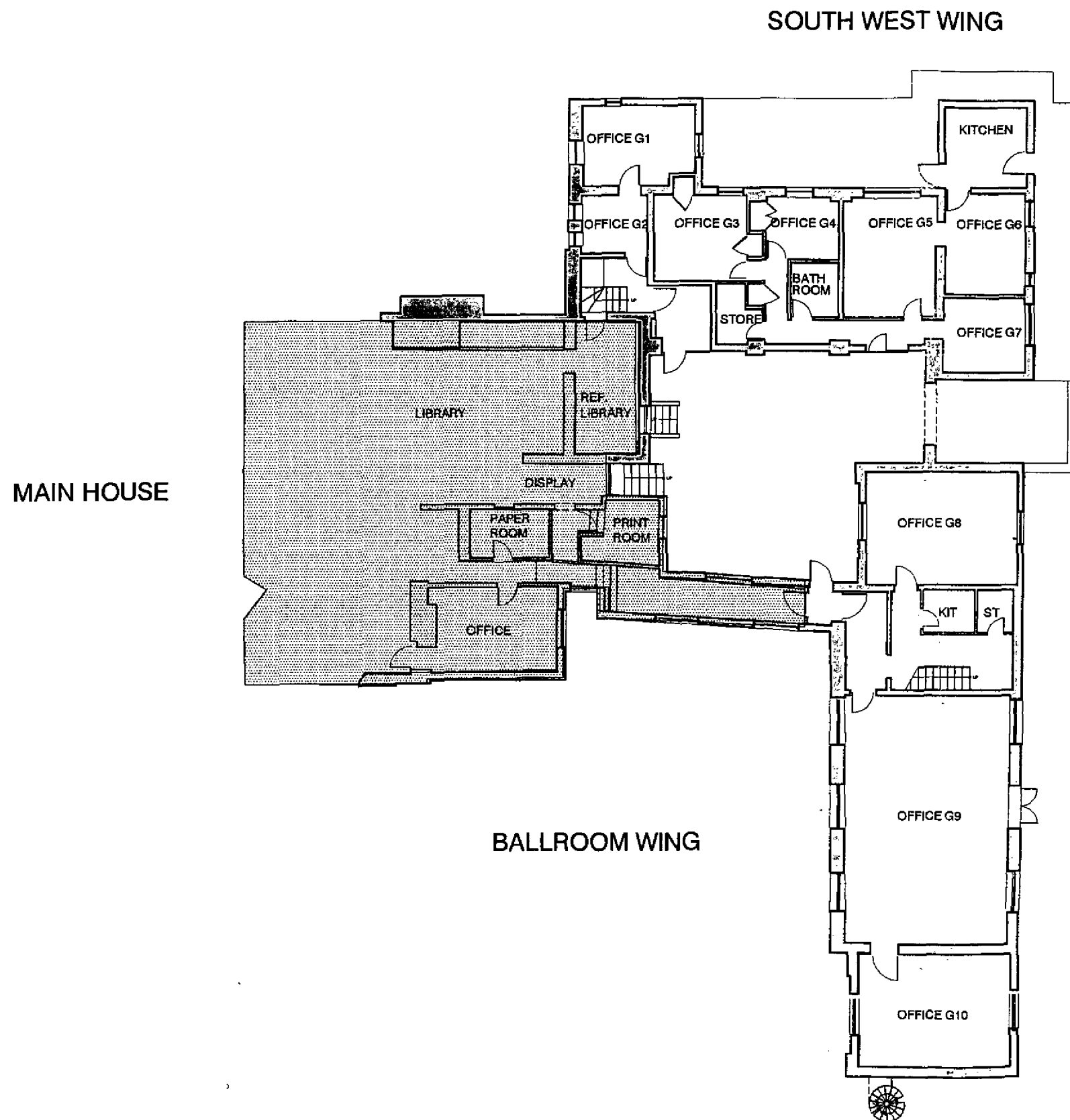

EXISTING FIRST FLOOR PLAN

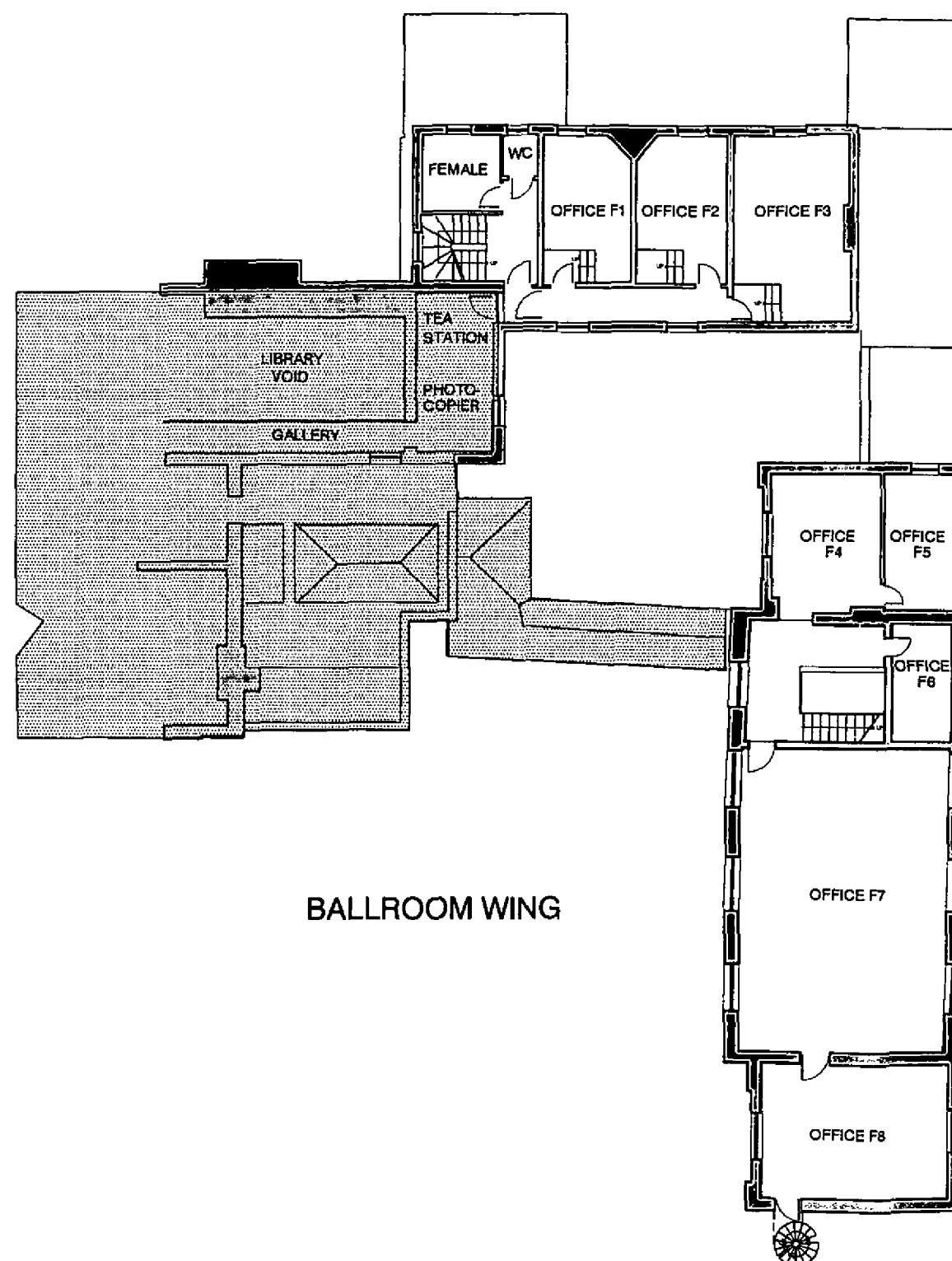

PROPOSED SECOND FLOOR PLAN

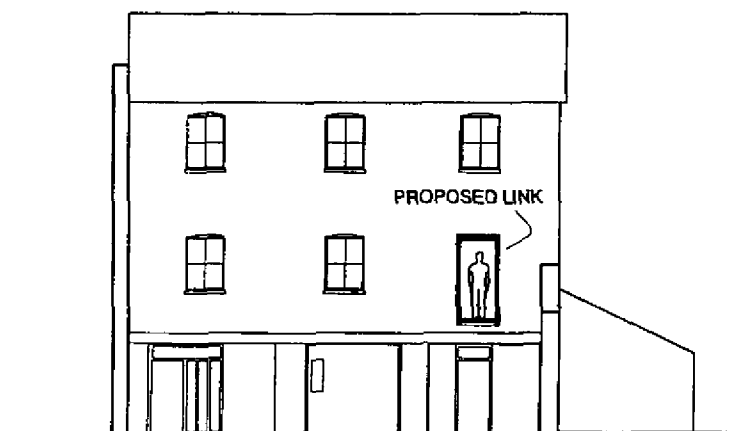
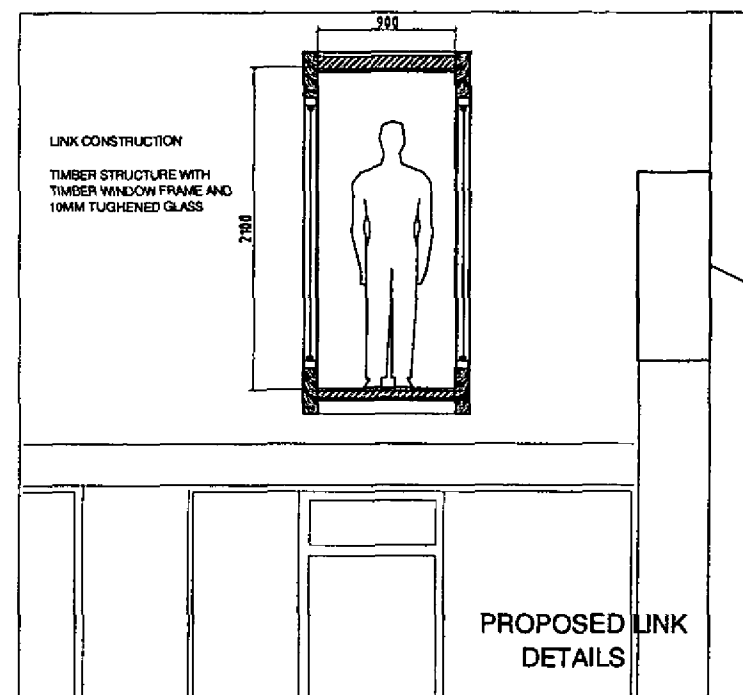

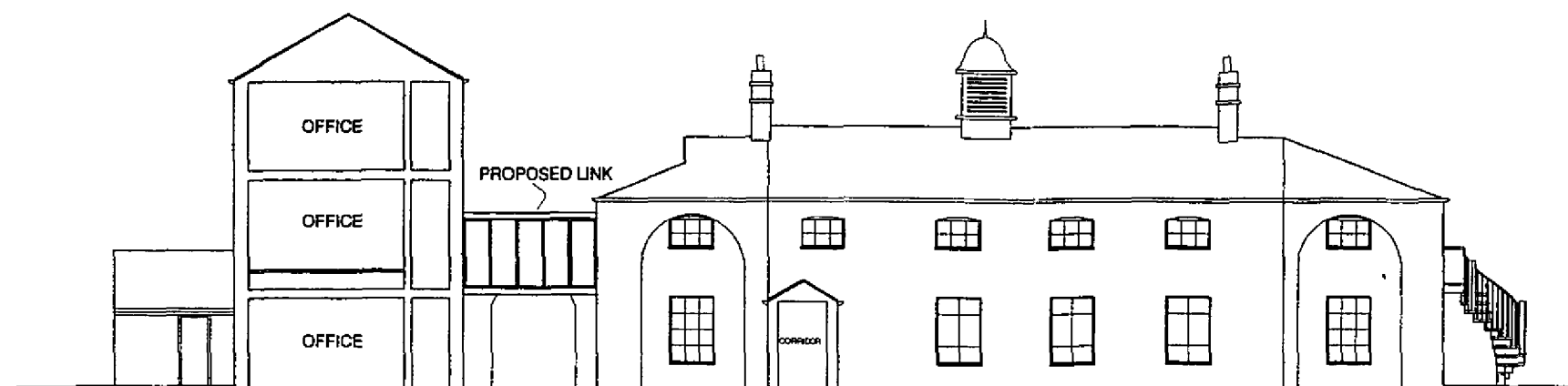
