### Introduction

On behalf of our client, Corporate Property, Welwyn Hatfield Borough Council, we write to enclose a full application for planning permission in respect of the above referenced site for:

'The redevelopment of the former Splashlands complex and surrounding area, comprising two development phases. Phase I to include construction of a high ropes adventure course and supporting ticket kiosk (115 sqm), and clearance of former lido area. Phase II to include redevelopment of the former lido site to provide a wet play area, extension and refurbishment of existing toilet block to provide a cafe, education room and ticket office (360 sqm extension), landscaping, and associated car park, access, and highways improvements.'

The proposal is a 'live' application currently under consideration by the Council following its submission in February 2011 (Ref No. N6/2010/3120/DC3). As part of the ongoing determination of the planning application, all material previously submitted in support of the proposals is being replaced with revised material, which now forms the application package. ### **Application Site**

The proposal site lies within Stanborough Park, in the Borough of Welwyn Hatfield. Stanborough Park occupies 56.34 hectares to the south west edge of Welwyn Garden City and provides residents and visitors with the opportunity for passive and active recreation. The park has been identified as one of the most visited and highest quality parks in the Borough and as a result, is subject to a dedicated Policy (CLT3 Stanborough Park) in the adopted Local Plan.

The development site comprises a 14.6 hectare area within Stanborough Park, and lies within the Green Belt. The site is currently owned by Welwyn Hatfield Council. The development site itself consists of the former Splashlands complex, the existing basketball court, and an area of open land to the north west of the Splashlands complex. In addition, the area of grass between the basketball court and the playground, the existing car park, and a stretch of Stanborough Road to the east of the park will be subject to improvements in the second development phase. The development site covers a total area of 3.85 hectares.

#### **Proposed Development**

This application seeks planning permission for the construction of a high ropes course, the redevelopment of the former Splashlands complex into a wet play area, the creation of a pavilion through the refurbishment and extension of the existing toilet block to include a café and education space, and improvements to the existing car park, highways, and access arrangements.

This development will be undertaken in two phases. Phase I will include the construction of the high ropes course, including a ticket kiosk, and clearance of the former Splashlands site to make it publicly accessible. The remaining development proposals will be undertaken as part of Phase II. The areas which comprise the two phases of the scheme are illustrated on the Phasing Requirements Plan.

The proposal includes the creation of floorspace for a ticket kiosk for the high ropes course which will have a footprint of 115 sqm (Phase I), and an extension of the existing toilet block which will increase the footprint of the structure by 360 sqm (total footprint 445 sqm) (Phase II). The primary use of both buildings will be supporting leisure (D2). Our analysis demonstrates that there will be no overall increase in the footprint of the buildings that have previously occupied the site. This is one of the key criteria set out by Policy CLT3.

### Summary

The proposal intends to enhance recreation and leisure opportunities for a wide range of local residents and visitors while bringing a disused, derelict space back into public use. Further, the proposed

development will create employment opportunities and improve the existing car park, access arrangements, and highway safety. A full assessment of these benefits is set out in the application Planning Statement and supporting documents which demonstrate that the scheme meets all material and local planning policy tests, including the appropriateness of the development in a Green Belt location.

All documents and drawings have been submitted in an electronic format via Planning Portal (PP-02354222). A disk containing electronic copies of the application documents has also been sent by mail. As this is a live application, it is not subject to a further planning fee.
