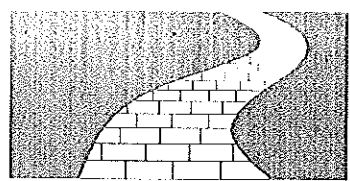

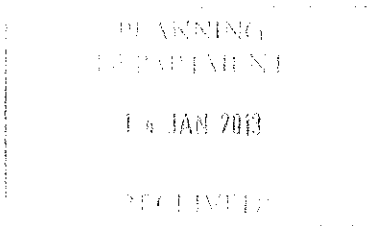

The Welwyn Hatfield Access Group has reviewed all the data submitted with this application via the Welwyn Hatfield Borough Council's website. We would like to tender the following comments:

Drawings

Drawing no. 6842/03/PO – Existing and Proposed Plans and Elevations

Ground floor

We note the proposed layout of the ground floor and the location and provision of toilets. Can you confirm where the wheelchair accessible toilet is located and the maximum travel distance from the proposed new dining area? Whilst we have downloaded A4 copies of the drawing we cannot determine any measurements.

We also note the indicative dining room layout. Please confirm if the tables and chairs in the dining area are fixed or moveable and there is adequate circulation space. We would remind you that a 750mm turning circle is required for a self-propelled wheelchair.

We further note the proposed layout of the serving area and cannot determine if there are any reduced height spaces for wheelchairs.

From the drawing we are unable to determine if there is level access at all entrances/exits. Could you kindly advise details of same?

Finally, with the enlarged facility will the number of car parking spaces increase and if so, what proportion of the total number of parking spaces will be disabled bays?
