Thank you for your re-consultation letter with regards to the discharge of Condition 1 relating to submission of the details of Construction Management Plan. HCC Highways have already provided comments on this submission under ref 6/2020/0378/COND. The Highway Authority has requested more information on point e) below.

The wording of Condition 1 states:

- 1. Development must not commence until a Construction Management Plan has been submitted to and approved in writing by the Local Planning Authority. The Construction Management Plan must include details of the following:
- a) Construction vehicle numbers, type, routing- satisfactory.
- b) Access arrangements to the site- satisfactory.
- c) Traffic management requirements satisfactory.
- d) Construction and storage compounds (including areas designated for car parking, loading / unloading and turning areas)-satisfactory

- e) Siting and details of wheel washing facilities- more information on the secondary access wheel washing location and facilities has now been provided and is satisfactory.
- f) Cleaning of site entrances, site tracks and the adjacent public highway- satisfactory.
- g) Timing of construction activities (including delivery times and removal of waste) and to avoid school pick up/drop off times- the deliveries will be outside the hours of 07.45-08.30hrs and 14.45-15.30hrs. this is deemed satisfactory.
- h) Provision of sufficient on-site parking prior to commencement of construction activities- on site. Satisfactory.

Subsequently, the construction of the development must only be carried out in accordance with the approved Construction Management Plan.

REASON: In the interest of highway safety in accordance with Policy SADM2 of the Welwyn Hatfield Borough Council Draft Local Plan Proposed Submission August 2016 and the National Planning Policy Framework 2019
