Thank you for consulting Sport England in respect of the details relating to the planning condition 3 which covers the details of the replacement hard play sports pitches.

I have considered the drawing (Replacement Hard Standing Sports Pitches Plan) that has been submitted to meet the requirements of this condition. I can advise that the dimensions and line marking proposals for the netball and tennis courts would appear to accord with Sport England's design guidance contained in Comparative Sizes – Outdoor Sports. I can also advise that the proposals for the surfacing and fencing would appear to meet Sport England's design guidance contained in Artificial Surfaces for Outdoor Sports. The proposals for the replacement facility would therefore appear to be fit for purpose from a design perspective and therefore address the purpose of imposing the condition.

I can therefore advise that Sport England would have **no objection** to the submitted details being approved to discharge planning condition 3 subject to the facilities being completed in accordance with the approved details as required by the condition.
