We would like to prune the three Oak trees by 20% and the Scotts Pine (Sketch Plan) in order to:
(i) maintain the health of trees and surrounding areas, including house. Please note that the house has suffered from subsidence in the past, While the trees in question did not cause the subsidence, it is has been recommended that we ensure they are reasonably pruned. The trees have not been pruned for three years, and
(ii) to avoid excessive shading to the house and garden.
