Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We wish to remove 2 trees from our rear garden at 17 Roundwood Drive.

The trees were planted by the previous owners so are not original trees to the area and do not have a TPO on them. When we moved in 12 years ago they were very small ornate trees framing a pathway. We believe them to be Chaemisuparis Elwoodi. Since then they have grown considerably and are probably just over 15ft tall and difficult for us to maintain. The branches are beginning to splay and if we tried to prune lower branches it would leave unsightly bare and dead growth. They are also growing close to the large central oak tree and apple tree in our garden. They are highlighted on the plan as cypresses (to the right of the common oak tree marked on site plan). When we sought advice from a local tree man about any possible work we could do to improve their appearance and reduce their height he recommended removal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
