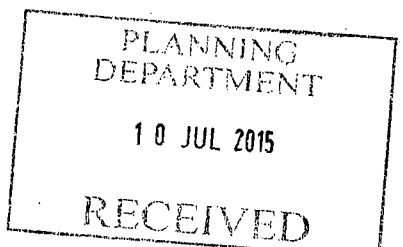

Dear Mark,

Unfortunately I can't seem to get the DataSpace System to log me in correctly, so I'm not able to comment on there. Therefore hopefully its ok to send the comments directly to you:

There is the possibility of local walkers submitting an application to record a path that was previously used between footpath 6 and South Drive, plan attached. Therefore including this route and dedicating it as a public right of way is wise. However, if they are looking for cycle use on this route as well, then it would need to be dedicated as a public bridleway, so it appears on the Definitive Map. Otherwise if they wish to only have a cycleway, then this can be discussed with Hertfordshire Highways. As with a bridleway, though this route would need to link to road or public right of way of the same or higher status, rather than public footpath 6.

The Rights of Way Improvement Plan does detail the desire for Northaw footpath 6 and Cheshunt footpath 59 to be upgraded, so horse riders and cycles can reach Cheshunt bridleways 17, 70 and 73 near Burnt Farmhouse, plan attached. Although this area is not directly associated with the proposed development, I believe this land is in the same ownership, so this proposal could also be discussed from a sustainable transport point of view.

I can see the benefit of the other permissive paths for dog walkers, but as they do not create direct links, are not identified as a need in the ROWIP (Rights of Way Improvement Plan) and would have no legal status, this is not something we would actively support.
