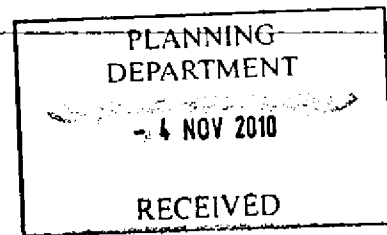

Re: - Tesco's Planning Submission for another of its supermarkets in the local area.

Sirs,

We strongly object to this proposal by Tesco primarily to build another of its stores so close to the one in Hatfield. The distance from the front door of that store to the traffic lights at the crossroads of Bridge Road and Broadwater Road, which is at the far end of the site, is 2.7 miles. Tesco gives the impression of little to no awareness of the nature of a Garden City or to its rationale.

Further, we already have the development of Sainsbury's great en-largement in full swing. We do not need another supermarket in the area.

Tesco's plans are primarily concerned with the retail store. The fact that its previous plans were turned down has not led them to encompass a concern for the whole of Welwyn Garden City and its nature and ethos as a Garden City.

Also, there are no plans to rebuild the bridge over the railway or to enlarge it. The present one was not built for a large increase in its use which would arise if the planning goes ahead.

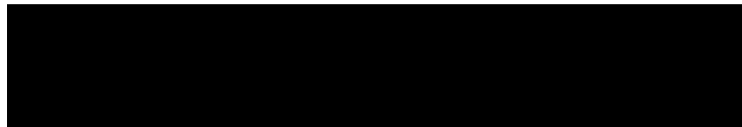
