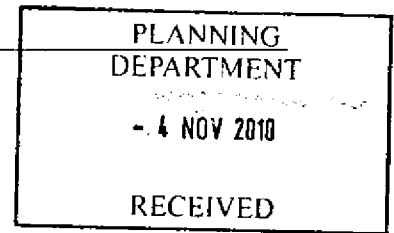

Dear Sirs,

I understand that today is the last day to voice my concerns about the proposed redevelopment of the Broadwater Road site in WGC.

I am against the Tesco plan for the following reasons:

- Another giant supermarket being Tesco or anyone else will destroy the trade of the Howard Centre, the few remaining shops in the town centre and have a huge negative impact on smaller shopping centres such as Woodhall, Hallgrove and Panshanger.
- A swimming pool in the centre of WGC is ridiculous. A better solution would be to rebuild one at Stanborough Park where there is ample parking and where visitors can enjoy other activities such as walking, sailing, fishing.
- Doctor's surgery and care home will hardly attract visitors from afar. Instead I would welcome a Luxury Hotel from any reputable chain. After all this seems to be lacking in WGC. And the people staying in the hotel would also use the existing shops in our town thus bringing welcome trade.
- Why another YMCA? There is a perfectly good one about 300 meters away in Peartree Lane. Again this kind of Association would keep visitors away rather than encourage them to come to our City.

Some additional housing would be a good idea.

I also believe that a square with restaurants and I don't mean more pizzerias or McDonald would give the people of WGC somewhere to eat and enjoy themselves
