Oak

The tree has no TPO but we are in a conservation area. The tree is in the eastern corner of the garden, adjacent to number 13 and backing on to Scholars Mews. The tree has significant infestation of honey fungus as a minimum, with intermittent hollowness, originating in the root system. There is noticeable die-back on the upper branches and work has previously been done to remove decaying branches which could endanger adjacent property and residents. An arborist has suggested complete removal to eradicate the fungus.

We would take advice but a replacement would face competition from adjacent oaks, holly and other mature trees, a beech hedge and I presume the honey fungus in the soil itself.
