We have a large oak tree at the front of our property.

A local arboriculturalist (Clinton from C E Wilkinson) has pointed out a number of issues with the tree and believes that it should be categorised as "dead, dying and dangerous" and believes that it should be promptly felled.

The position of the tree is a danger both to residents in my house and to the public as it is adjacent to the public highway.

Specific issues identified are bacterial canker on the north side, rotting on the bottom of east side and most concerningly 50% of the cambian area has died. As a consequence most of the trunk is hollow and some of the canopy is going brown, dying. A number of large boughs have already fallen over that couple of years.

Could I please request an urgent inspection - I have been recommended to serve a 7 day notice as it is deemed a danger to the public.
