When we applied for (and were granted) permission to remove the laurel hedge that ran along the driveway, we said we would leave a small laurel return from the front hedge. Once the side hedge was removed, it led to a large stump (H1) remaining on the edge of the return. As the exposed stump is low and dark, it does cause damage to vehicles accessing the hard standing to the front of the property. We would like to remove the stump. There are still some live branches which form part of the front hedge by growing sideways, but we will encourage neighbouring upright stems in the front hedge to cover any gaps in the first instance. If this is not working, we will plant another laurel.
